# A History of Braddock Heights



Braddock Heights has a rich and interesting history. Born as a mountain resort at the end of the 19th

century, it featured a trolley system in its heyday that ferried guests to the many hotels, summer homes and boarding houses that dotted the crest of Braddock Mountain.

A thriving vacation spot for many years, visitors came from far and wide to enjoy the famed amusement park, clear skies and great views. Over time, the resort closed and Braddock Heights became more residential.

Today, the flavor of the community continues to change as it experiences a wonderful period of revival and restoration. Many of the outstanding historic homes are being restored to their former glory, and Braddock Heights' many residents today celebrate its rich history while enjoying the vitality of everyday life on the mountain.

Nestled at the southern end of the Catoctin mountain range, Braddock Heights offers the best of small town living with easy access to the shops, restaurants and amenities of downtown Frederick as well as the big city attractions of Washington, D.C. and Baltimore.

## Community Association

The Braddock Heights Community Association (BHCA) exists for the benefit of the community and is dedicated to addressing its needs — from traffic control to community events to managing the community pool and recreation center. Annual membership supports the activities that bring our residents together to celebrate the community and provide a unified voice on local issues. Membership is open to all residents of Braddock Heights. \$35 annual fee per household.
